TERRACE WITH SPA AND SUMMER KITCHEN

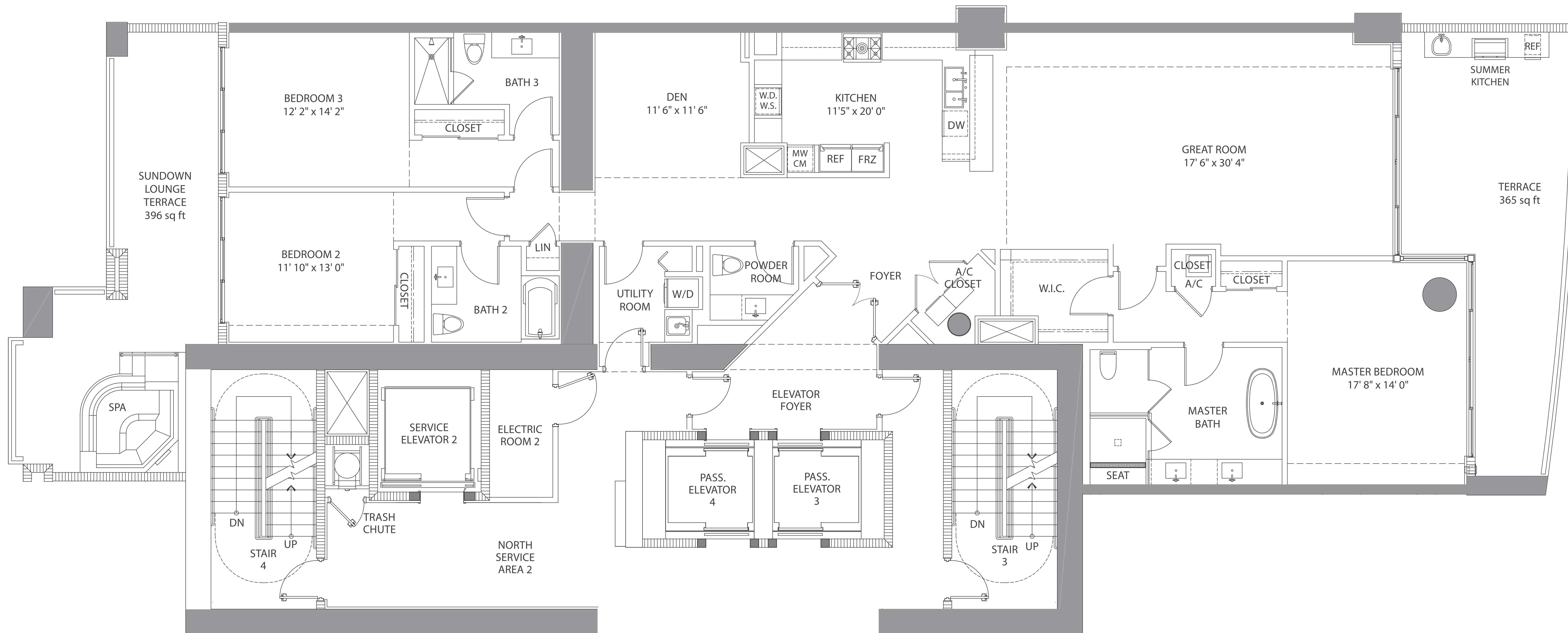

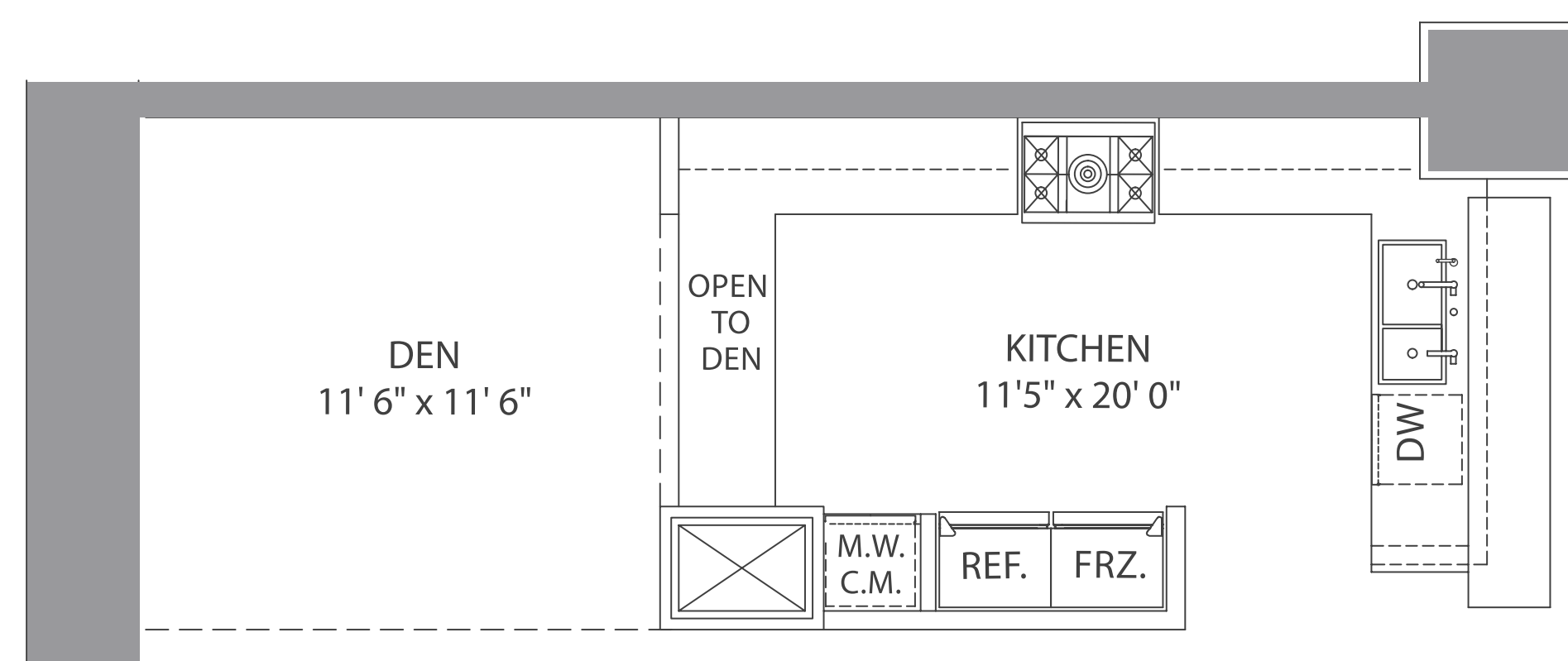

TERRACE WITH SPA AND SUMMER KITCHEN



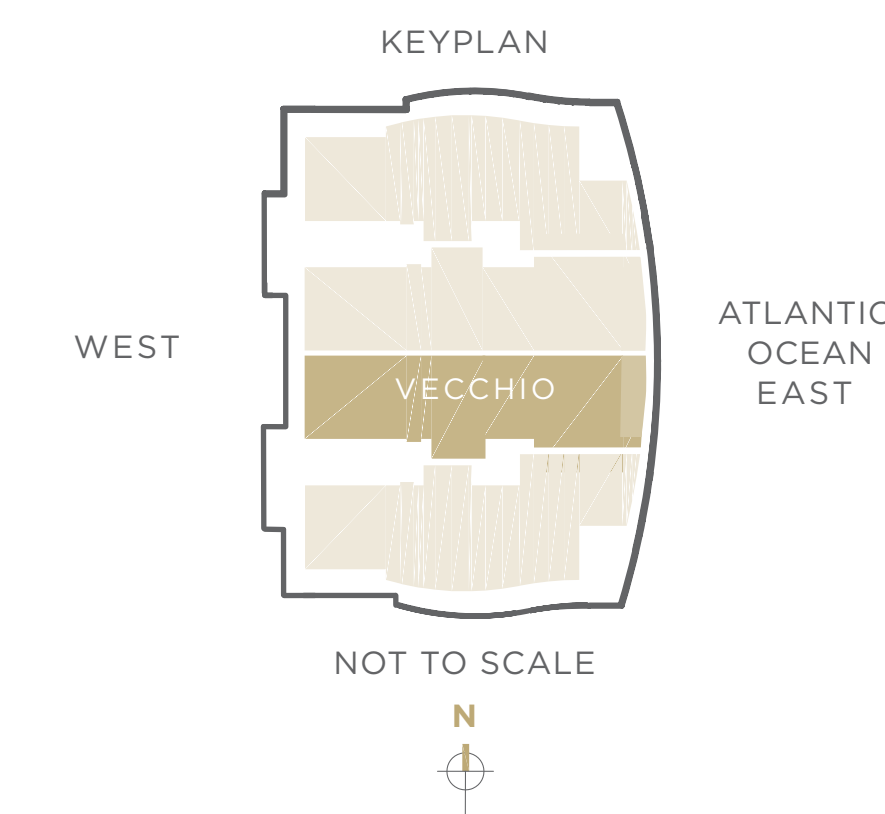
VECCHIO OPTIONAL PLAN

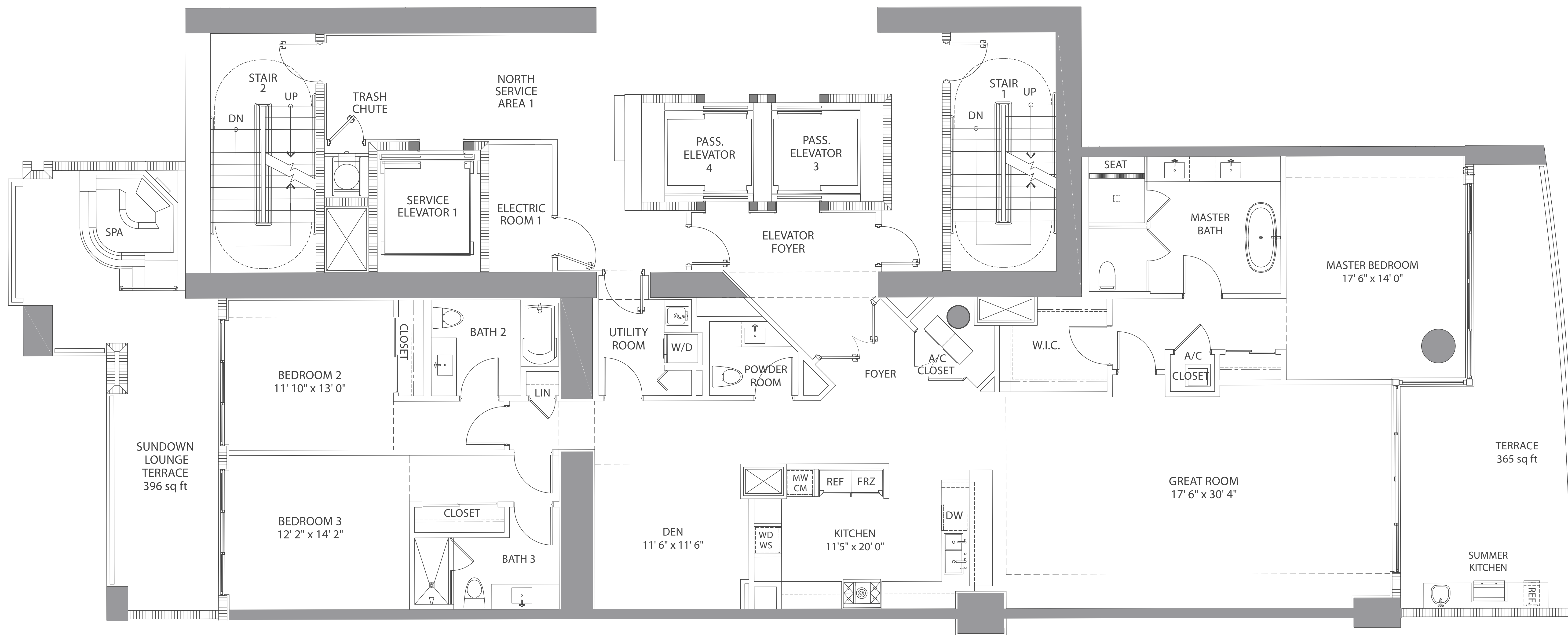

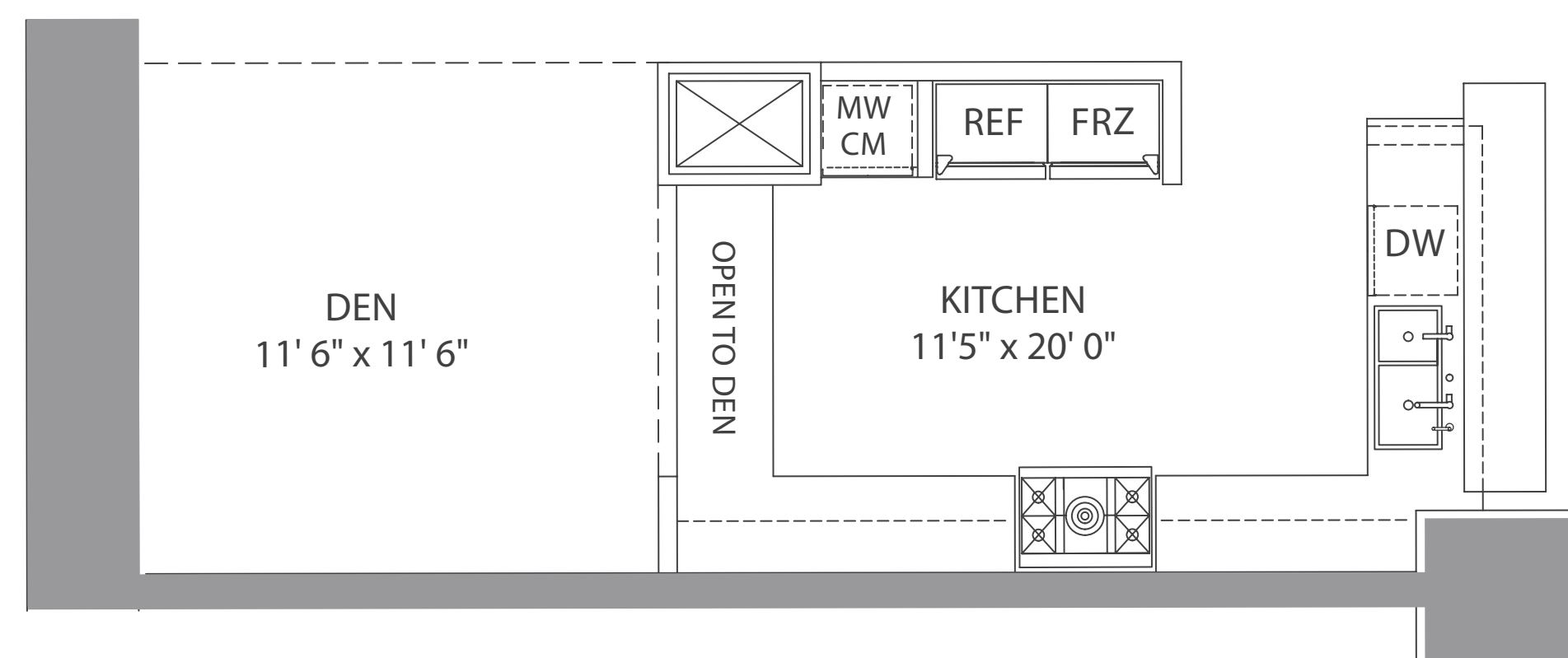

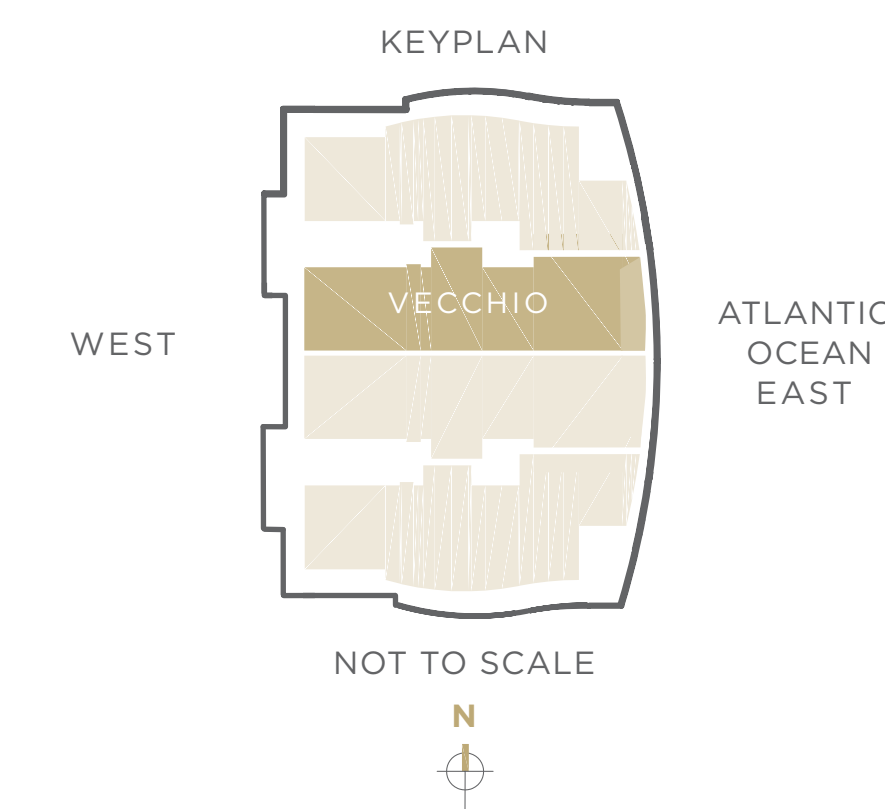
VECCHIO OPTIONAL PLAN
